

## ACCEPTANCE OF TERMS AND CONDITIONS

I state that I have read and agree the following terms and conditions

I undersign hereby declare to:

- be more than eighteen years;
- be in good physical condition that allows me to use the "Giro Club Service":
- hold harmless and indemnify RCS Sports & Events Srl any liability in connection with any accident should happen depending on the participation in the "Giro Club Service", except that this depends on the direct responsibility of RCS Sports & Events Srl.

<u>In relation to the "FLY EXPERIENCE"</u>: the assessment of the feasibility of the flight is at the discretion of the pilot that shall evaluate eventual adverse weather conditions such as a) low visibility; b) strong wind, c) excessive turbulence.

<u>Force Majeure</u>: The Hospitality services will also be suspended in the event of cancellation of the stage. The Participant acknowledges and agrees that in the event that the stage indicated in the application form does not take place due to force majeure (including, without limitation weather events, security, strikes, etc..) and/or for the reasons mentioned indicated for Fly Experience above, shall pay a fee to RCS Sports & Events Srl equal to 20% of the amount provided in the application form.

<u>Waiver:</u> In case of cancellation, even partially, of the service acquired by the Client, the same will pay to RCS Sports & Events Srl a fee of 20% of the amount of the service acquired over the following penalty:

- 30% of the consideration in the event of cancellation notified from 30 to 15 days before date of the stage;
- 50% of the consideration in the event of cancellation notified from 15 to 7 days before date of the stage;
- 80% of the consideration in the case of renunciation communicated from 7 to 1 day before the date of the stage.

In the event of a reduction of the number of participants the fee remains unchanged.

<u>In relation to the "DRIVE EXPERIENCE"</u>: children under 12 are not allowed in this event.

Children between the ages of 12 and 17 shall require a written parents permission - as indicated in Art. 133 of F.C.I. - and subject to Director of Giro d'Italia confirmation.
